Scott Forester gave a presentation about Hardy Industry's improvements to the business and to improve the odor control

Kristen Jevnikar shared her commentary on why she would like the trustees to reconsider the decision made from previous meeting.

Trustee Gabe Cicconetti asked Chairman Chuck Hillier to please only go on facts and not opinions going further on the rezoning debates for 1251 Madison Avenue.
