MINUTES

The Board of Painesville Township Trustees met for a regular meeting at 11:00 A.M. on Tuesday, July 12, 2016 55 Nye Road. Present: Trustees Gabe Cicconetti, Chuck Hillier, Josh Pennock, Legal Advisor Mike Lucas and Administrator Michael Manary.

Chuck Hillier asked for a moment of silence to honor Werner Barthol, The former Legal Advisor who passed away.

Chuck Hillier introduced the interim Legal Advisor Mike Lucas

Various topics, agenda items and departmental matters were brought before the board including the approval of minutes from the previous meeting.

LAKE COUNTY SHERIFF'S REPORT:

Captain Dondorfer gave an update on activity in the Township

SUMMARY OF WORK SESSION:

Administrator Manary summarized the work session noting the following:

- We had a discussion on renewing the road levy
- We discussed the joint economic development district that we are working on
- Bob Sidley came to the work session and the Trustees explained their vision for the future of the corner of Bowhall and Madison Avenue

OLD BUSINESS: None

NEW BUSINESS:

Beth Knezevich of 397 Manhattan Parkway asked the Trustees about restoration of the Vial of Life program in the Township

John Muzik of 45 Coventry Drive would like to see some type of resolution thanking the Sheriff's Department and the Fire Department for the valuable services they provide.

Kelli Raines of 145 Larchwood Drive shared her commentary on why she feels the neighbor house at 137 Larchwood should not be zoned as Commercial. Captain Dondorfer offered to work with the resident on this.

DEPARTMENT REPORTS:

- SERVICE DEPARTMENT: At the last meeting a resident from S. Doan came in to discuss their
 concerns on flooding. The Service director went out there with the Storm Water Department to
 look at the ditch and they agreed that it needed cleaning. We have a contract with Paul Hack to
 do the cleaning. He was hoping to do it Thursday but it has to be really dry to do it.
 The section of Madison Avenue sidewalk that wasn't covered under the SRTS Grant has been
 - completed. The grass will be planted in September.
 - The sealing of the stamped concrete on Mentor Avenue has been done from Nye Road to the Mentor line and we still have a section on Nye Road and should be done in a couple of weeks. The concrete work on Big Rock will start this week.
- FIRE DEPARTMENT: We had a significant fire and the smoke alarms alerted everyone and they
 got out.

We assisted with several fires in Perry and Painesville City

The K-9 unit was called out 5 or 6 times last month.

Two of our residents last month experienced cardiac arrest and with CPR and other procedures they both had a good outcome

We had 11 cases of using Narcan to reverse the effects of Heroin, Fentanyl and unconscious patients. 6 of these cases were verified. The Fire Department approached the schools to educate them on the effects.

We have had a couple of problems with vehicles and we think we have a blown head gasket in one of the squads.

Station 2 on Bowhall Road did a really nice job cleaning up that station. They did a lot of the work themselves and had items donated to them.

Another issue we are having at station 2 is people are parking and walking in the back parking lot playing the game looking for monsters.

Last month our crew along with the Grand River crew was given an award by Metrohealth for their extraordinary actions to save an accident victims leg.

- ZONING DEPARTMENT: None
- LEGAL ADVISOR: There is a current resolution 2016-52, a resolution to reopen to reconsider the decision of denying the rezoning of 1251 Madison Avenue for further discussion, this was based on a request on the May 17, 2016 meeting to reconsider which the Trustees acted upon and the Trustees have been considering this and to my understanding at this point in time they are going to independently initiate more expansive rezoning that would include the parcel at 1251 Madison Avenue property, so it would be my recommendation that the Trustees just to tidy this up, make a motion to permanently table thereafter remove from the Agenda the 2016-52 resolution to reopen and reconsider the decision of denying the rezoning of 1251 Madison Avenue for further discussion.

Just for clarification there is going to be more than one property that will be initiated for rezoning in addition to the 1251 Madison Avenue property and again it will be starting at the statutory required ground level which basically will mean that the Trustees will request that the matter be sent down to the zoning commission. The zoning commission will schedule a public hearing and correspondingly the planning commission will receive a copy of the proposed rezoning as determined by the Trustees. There will be a public hearing and they will consider the pros and cons of the recommendations made by the Lake County planning commission, thereafter the zoning commission will then recommend approval or disapproval of the rezoning, it will be sent up to the Trustees, The Trustees will then schedule a public hearing and subsequent to the public hearing they will either vote to accept, reject or modify in part the recommendation of the trustees in regarding of rezoning.

 ADMINISTRATOR: About a year ago the County Treasurer Lorraine Fende started a program to collect delinquent property taxes. Last month we received our first check from her efforts for \$105,000.00 for previously unpaid property taxes and her letter indicates that there will be more coming.

There is a house at 84 Johnnycake Ridge which the neighbors have approached us on previously, The white structure that has been abandoned for years, We did make contact with the owners of that property and they will demolish that structure by the end of July.

We have had complaints from the Northeast section of the Township about flooding that occurs under the railroad tracks at Bacon Road. Bill Thompson the service director and I will be meeting the Lake County Engineers office and Norfolk Southern Railroad tomorrow morning to look at it. The Railroad tried to jet out the culvert and he found a blockage. We are going to try and convince them to replace that culvert.

Our plans are underway for the Family Fun Day which will occur on August 27th.
