The Board of Painesville Township Trustees met for a regular meeting at 7:30 P.M. on Tuesday, November 27, 2018 at 55 Nye Road. The meeting was called to order at 7:34 P.M. by Chairman Cicconetti. Present: Trustees Gabe Cicconetti, Chuck Hillier, Josh Pennock, Administrator Michael Manary, Legal Advisor Matt Lallo, Fiscal Officer Michael Patriarca.

Various topics, agenda items and departmental matters were brought before the board including the approval of minutes from the previous meetings November 6, 2018 and November 19, 2018.

#### SUMMARY OF WORK SESSION:

Administrator Manary summarized the work session noting the following:

- The Trustees discussed the Township's Brush pickup that we provide.
- The Trustees discussed the Project Hope collection that Trustee Cicconetti started for Christmas at Project Hope.
- The Trustees rescheduled January 22<sup>nd</sup> meeting to be held on January 15<sup>th</sup>.
- The Trustees discussed the Children's Christmas Party that will be coming up.
- The Service Director discussed his road and paving program for 2019.
- The Service Director discussed a scheduled truck replacement for 2019.
- The Service Director discussed some medical issues for employees that will be missing some time soon.
- The Fire Chief reported on two fires that happened in the Township this past month.
- The Fire Chief reported that one of the Fire Trucks is being recalled for service.
- The Fire Chief discussed several grants that they have applied for in the past.
- The Fire Chief reported that the Lake County Fire Chief's Association is giving citizens awards to two Township residents.
- The Zoning Inspector reported on the terms for a couple of members on the Board of Zoning Appeals and the Zoning Commission.
