MINUTES

The Board of Painesville Township Trustees met for a regular meeting at 11:00 A.M. on Tuesday, January 7, 2020 at 55 Nye Road. The meeting was called to order at 11:01 A.M. by Chairman Hillier. Present: Trustees Gabe Cicconetti, Chuck Hillier, Josh Pennock, Administrator Michael Manary, Legal Advisor Stephanie Landgraf, stepping in for Matt Lallo, Fiscal Officer Michael Patriarca was excused.

Chairman Chuck Hillier opened up Public Hearing for Zoning Case 19-ZC-08, Proposed text amendments to section 27-TC District at 11:03 A.M.

Zoning Inspector Rich Constantine read the history of the Zoning Case 19-ZC-08 as follows. On August 5, 2019 an application was submitted to propose text amendments to Section 27. On September 25, 2019 the Lake County Planning Commission issued a recommendation recommending approval with modifications. On October 7, 2019 the Painesville Township Zoning Commission held a public hearing and decided on that date to continue the hearing. On November 11, 2019 reconvened the public hearing and decided once again to continue that hearing. On December 9, 2019 the Painesville Township Zoning Commission reconvened the public hearing and closed that hearing. On December 9, 2019, the Painesville Township Zoning Commission at their regular meeting, voted to recommend to the Township Trustees the approval as modified of these proposed text amendments. On December 17, 2019 the Trustees received the recommendation and the Trustees where by motion they set up a public hearing for January 7, 2020 to address this case. On December 27, 2019 there was a legal ad published for this hearing on behalf of the Trustees.
