Present: Trustees Gabe Cicconetti, Chuck Hillier, Josh Pennock, Administrator Michael Manary, Fiscal Officer Michael Patriarca, Legal Advisor Jeremy Iosue.

Various topics, agenda items and departmental matters were brought before the board including the approval of minutes from the previous meeting April 21, 2020.

SUMMARY OF WORK SESSION:

Administrator Manary summarized the work session noting the following:

- The Trustees held an informal meeting with representatives from SAFstor to go over their plans for a building on Mentor Avenue for safe storage.
- The Trustees agreed that Trustee Cicconetti is going to write an article for the next newsletter.
- The Trustees discussed setting up another meeting to discuss the Joint Economic Development District.
- The Trustees discussed law enforcement with ATV's and 4 Wheelers in the Township.
- The Trustees discussed movie night in July and there was no decision made.
- The Fire Chief talked about the command vehicle has been removed from the County and is back in the Townships possession.
- The Fire Chief talked about his budget and loss of revenue.
- The Fire Chief discussed repairs at station 3.
- The Service discussed the lawn and garden awards for this summer.
- The Service Director discussed tweaking the Curbside Brush Pickup on June 8th since the students at Riverside High School will not be able to participate with us due to the Coronavirus.
