The purpose of the meeting: Discuss and take action on the Township's noise resolution as it relates to recent State legislation and, as a separate matter, to discuss a Preliminary Development Plan of a proposed subdivision within the Township.

The purpose was to consider the purchase of property for public purposes and to consider confidential information related to the marketing plans, specific business strategy, production techniques, trade secrets, or personal financial statements of an applicant for economic development assistance

Chairman Gabe Cicconetti made a motion to close the meeting at 1:36 P.M., seconded by Chuck Hillier passed unanimously.

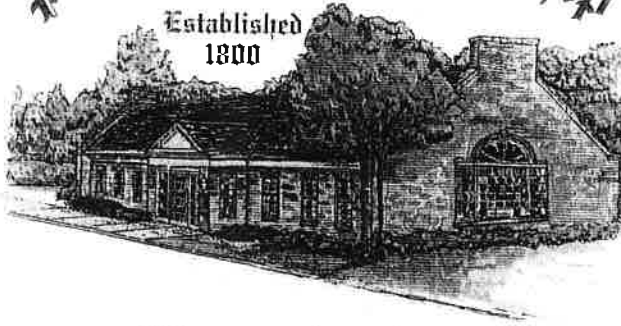

Resolution No. 2022-086

### RESOLUTION TO MODIFY THE NOISE CONTROL REGULATIONS FOR PAINESVILLE TOWNSHIP

**WHEREAS**, The Painesville Township has a current Noise Control Regulations, codified as Resolution 2000-52 to regulate noise disturbances within the Township including, but not limited to Explosives, Firearms and other devices; and

**WHEREAS**, the Township wishes to exercise its authority to regulate noise in the Township, while also allowing for compliance with Ohio Revised Code Section 3743.45 as it relates to fireworks and other related devices.

**NOW THEREFORE BE IT RESOLVED** by the Trustees of Painesville Township, Lake County, Ohio, as follows:

**SECTION 1.** That the Trustees of Painesville Township hereby modify Section 3 of the Township Noise Regulations as originally enacted in Resolution 2000-52 as follows (emphasis added):

#### SECTION 3: SPECIFIC PROHIBITIONS

Explosives, Firearms and Similar Devices



The using of firing or explosives, firearms or similar devices which create impulsive sound so as to cause a noise disturbance across a residential real property boundary or on a public space or right of way, without first obtaining a special variance. This Resolution shall not apply to permitted hunting, target shooting, **nor shall this resolution apply to fireworks discharged in accordance with Ohio Revised Code Section 3743.45, OAC Section 1301:7-7-56(Z), State, Federal and Local fire and building codes, and any related Township legislation.**

**SECTION 2.** This Resolution shall be in effect from and after the earliest period allowed by law.

**SECTION 3.** That the Trustees of Painesville Township hereby find and determine that all formal actions relative to the passage of this Resolution were taken in an open meeting of the Trustees, and that all deliberations of the Trustees which resulted in formal were taken in meetings open to the public and in full compliance with application legal requirements, including Section 121.22 of the Ohio Revised Code.

NOW, THEREFORE, this Resolution shall be in full force and effect upon its passage and approval by the Board of Trustees and as further provided under Ohio Law.


