Resolution No. 2022-100

RESOLUTION TO OBJECT TO THE RENEWAL OF A LIQUOR LICENSE #6433637, NORM & MIKE, INC., DBA CITY LIMITS BAR & GRILL OR AS, LAKE DINE & DANCE

Whereas, a bar / restaurant was operating at 520 Fairport Nursery Road in Painesville Township. The liquor license is in the name of Norm & Mike Inc. DBA City Limits Bar & Grill. This bar is now operating under the name of Lake Dine & Dance. The owner of the bar is Charles Titchenell; and

Whereas, the Painesville Township Board of Trustees have received serious complaints about illegal activity at this location that jeopardizes the public health and safety of the residents and businesses in the immediate area of this location; and

Whereas, the Lake County Sheriff's Office has responded to an excessive number of calls to this location. The nature of the calls range from fighting, vandalism, disorderly conduct, driving while under the influence, public intoxication, gun shots in February 2017, and more. The gun shot incident in February of 2017 was not reported to the Sheriff's Office by the management of the bar; and

Whereas, the Lake County Sheriff's Office has provided a summary of their history with the business through September of 2020 and which is attached to this Resolution; and

Whereas, the criminal complaints and activity have continued unabated over this period of time, and beyond, despite counseling from the Sheriff's Office that the activity must stop; and

Whereas, the Board of Trustees of Painesville Township have previously filed an objection to the renewal of the liquor license for this establishment, on or about December 20,2020 and subsequent to that filing there have been additional developments which justify the denial of any renewal of this permit. Those developments are as follows:

-A shooting on the grounds of the Lake Dine and Dance at 520 Fairport Nursery Road from multiple persons who discharged between 70-100 rounds and resulted

in an injury to a minor female at approximately 1:00 a.m. on July 5, 2021. A copy of the Lake County Sheriff's Office Press Release is attached;

- -A sustained Nuisance Charge that required Lake Dine and Dance to close down for a year, Lake County Common Pleas Case No. 21CV001254; and,
- -Several citations for code violations.

Section 1. That the Painesville Township Board of Trustees hereby object to the renewal of the liquor license for this establishment and the Painesville Township Board of Trustees request that a hearing be conducted in the county seat of Lake County, Ohio; the Township Administrator shall file a copy of this Resolution with the State of Ohio, Division of Liquor Control.

Section 2. This Resolution shall be in effect from and after the earliest period allowed by law.

Section 3. That the Trustees of Painesville Township hereby find and determine that all formal actions relative to the passage of this Resolution were taken in an open meeting of the Trustees, and that all deliberations of the Trustees which resulted in formal were taken in meetings open to the public and in full compliance with application legal requirements, including Section 121.22 of the Ohio Revised Code.

NOW, THEREFORE, BE IT HEREBY RESOLVED, this Resolution shall be in full force and effect upon its passage and approval by the Board of Trustees and as further provided under Ohio Law.
