FOR IMMEDIATE RELEASE: BLASÉ-NEMETH ROAD CLOSURE IN PAINESVILLE TOWNSHIP

Blasé-Nemeth Road in Painesville Township between US 20 (North Ridge Road) and the Lake County Solid Waste District (Landfill) will be closed on Monday, May 8, 2023. The closure is necessary while the facility has maintenance performed on it's weigh scales. The closure is scheduled to begin at 6:00 am. The road will be open by the end of the work day.
