#### **MINUTES**

On October 23, 2023 an application was submitted.

On December 11, 2023 the Painesville Township Zoning Commission held a Public Hearing and continued the Public Hearing for the next scheduled meeting.

On January 8, 2024 the Painesville Township Zoning Commission continued the Public Hearing and closed the Public Hearing and issued a recommendation to approve with modifications.

On January 24, 2024 the Trustees received the recommendation and the Trustees by motion set up a Public Hearing for February 6, 2024 to address this case.

On January 26, 2024 a legal ad was published for this hearing on behalf of the Trustees.

With no response Trustee Cicconetti closed the Public Hearing at 7:32 P.M.
