• 2023-0003-ZC: Site plan review for a 2,802 sq ft Popeyes Restaurant at 2168 Mentor Ave.

Michael Couch spoke for the request. The request is for a Popeyes Restaurant with a double lane drive through that will merge into a single lane window and landscaping.

Chairman asked how many vehicles could be queued.

The Applicant replied thirteen or more vehicles. The drive through is a double lane that will merge into a single lane at the window.

Zoning Inspector Harley DeLeon let the Commission know that the applicant has met all standards of Zoning. Staff has worked closely with the Applicant to assure the standards have been met. Staff would recommend approval as submitted.

Jim Corrigan shared a concern for line of sight due to a tree and mound near Waterford and Mentor Avenue.

A discussion was held pertaining to the mound. The members asked to have the mound moved closer into the site.

A discussion was held with Zoning Inspector Harley DeLeon and the Applicant regarding mound requirements in the Resolution.

Chairman asked regarding the color scheme following the Western Reserve requirements. Zoning Inspector Harley DeLeon replied yes.

Chairman entertained a motion.

Jim Corrigan made a motion to approve Case 2023-0003-ZC with the condition(s) as follows:

- 1. Setting the earth mound two (2) feet further from Mentor Avenue.
- 2. Removing the Honey Locust tree at the intersection of Waterford and Mentor Avenue.

The Applicant needed clarification if a tree previously discussed, would need to be removed from the landscaping scheme.

Chairman replied yes.

Zoning Inspector Harley DeLeon needed clarification that the mound would need to be moved at least one to two feet further into the site.

A discussion was held.
